If the GST rate charged on the goods is 18%, the trader will charge Rs.5,900 for the goods. The Goods and Services Tax (GST) has absorbed several local taxes levied on goods and/or services. Within IGST, the body responsible for collecting taxes is the central government. Therefore, the UTGST will be levied in addition to the CGST in the territories of the Union. UTGST applies to the supply of goods and/or services in the Andaman Islands and Nicobar, Chandigarh, Daman Diu, Dadra, Nagar Haveli and Lakshadweep. The revenue generated by SGSTs is exclusively claimed by the respective state government. Central Goods and Services Tax or CGST Just like State GST, CGST's Central Goods and Services Tax is a tax under the GST regime that applies to intra-State transactions (within the same State). It is governed by the SGST Act. For example, if a West Bengal merchant has sold goods to a customer in Karnataka for a value of 5,000 Rs, then IGST will be applicable as the transaction is an interstate transaction. The collected IGST is Rs.900, which will go to the central government. The total amount to be borne by the trader, in this case, will be Rs.5,900. 3. The new system of indirect taxation under the Goods and Services Tax (GST), introduced on 1 July 2017, has created considerable confusion about the impact the new system of taxation will have on businesses and the payment of taxes. IGST is governed by the IGST Act. UTGST shall replace the SGST in the territories of the Union. If the GST rate charged is 18%, it will be divided equally in the form of 9% CGST and 9% SGST.
